

Costa Rica and GoPro Sweepstakes 2024

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

The **Costa Rica and GoPro Sweepstakes 2024** (the “Sweepstakes”) starts on **11/19/24 at 12:00 AM ET** and ends on **12/31/24 at 11:59 PM ET** (“Sweepstakes Period”). The administrator’s computer is the official time-keeping device for this promotion.

ELIGIBILITY:

The Sweepstakes is open to legal residents of the United States and the District of Columbia who are 18 years of age or older as of the date of entry. Employees of **Visit Costa Rica** (the “Sponsor”), **Costa Rica and GoPro** (the “Prize Provider”), their respective subsidiaries, distributors, affiliates, promotion and advertising agencies, and members of their immediate family (spouse, parents, children, siblings, and their spouses), and persons living in the same household (whether or not related) are not eligible to enter or win. Void where prohibited by law. The Sweepstakes is subject to all applicable federal, state, and local laws. Participation constitutes an entrant’s full and unconditional agreement to these Official Rules and to the decisions of the Sponsor and Prize Provider, which are final and binding in all matters related to the Sweepstakes. HOW TO ENTER:

During the Sweepstakes Period, there is **one (1)** way to enter:

- **Website:** Visit <https://visitcostarica.com/capture> (the “Website”) and follow the directions to complete and submit the registration form to receive one (1) entry (“Entry”). Entries must be received by **12/31/24 at 11:59 PM ET** to be eligible.

Entries generated by script, macro, or other automated means are void. Limit one (1) Entry per person per day for the duration of the Sweepstakes Period. You may only use one (1) email address to enter the Sweepstakes. All Entries become the property of the Sponsor and will not be returned. In the event of a dispute, the authorized account holder of the email address used to register will be deemed the entrant. RANDOM DRAWING:

One (1) potential Grand Prize winner will be selected in a random drawing on or about **1/5/25** from among all eligible entries received throughout the Sweepstakes Period. Odds of winning depend on the number of eligible entries received. The drawing will be conducted by the Prize Provider.

WINNER NOTIFICATION:

The potential winner will be notified by **email**. The potential Grand Prize winner will be required to execute and return an affidavit of eligibility, a liability release, and, where lawful, a publicity release within **seven (7) days** of notification. If the documents are not returned within the specified time, the prize will be forfeited and an alternate winner may be selected. The Grand Prize winner will be issued a Form 1099 for tax purposes and must submit their social security number.

GRAND PRIZE:

The Grand Prize consists of **an unforgettable Costa Rican adventure for two (2)**, valued at **\$5,500**. This prize package includes:

- Round-trip, coach-class airfare for two (2) from a major airport near the winner's home to San José, Costa Rica
- Private airport transfers
- Four (4) nights' hotel accommodations (single room, double occupancy) at luxurious hotels

- Guided tours, including Poás Volcano National Park and other excursions, such as zip-lining or kayaking
